RULES/REQUIREMENTS AND ACKNOWLEDGEMENT FORM

- 1. **Personal Characteristics**: In order to be eligible to participate, contestants and their parent/legal guardian must certify to the Personal Characteristics in this section along with all of the other rules by signing this Form.
 - a. Candidates must be a minimum of 10 years of age and not have achieved her 14th birthday by August 14, 2024.
 - b. Must be a U.S. Citizen. Contestant, Parent or Legal Guardian must currently be a resident of Winnebago County IL or the contestant is attending a Winnebago County school. Contestants from another county may compete if their country does not have a pageant for their given age division or if approved by the Winnebago County Fair Board. We will request a copy of your parent's/legal guardian's driver's license for proof of residency. If outside of Winnebago County, we will need proof of enrollment in a Winnebago County School for the 24-25 school year.
 - c. Can never have been convicted of a felony offense.
 - d. Was born female and have always been a female.
 - e. Must be single and never have been married, divorced or had a marriage annulled.
 - f. Can never have been pregnant.
 - g. Does not use or consume any illegal controlled substances or abuse the use of alcohol or other dangerous substances.
 - h. Is of good moral character. Has never performed any act or engaged in any activity or employment that is or could be characterized as immoral or indecent. Attests that any and all online depictions associated with the contestant's name or likeness including but not limited to Facebook and any other social media pages are consistent with standards and dignity of the Winnebago County Fair Queen Pageants.
- 2. Anyone holding a current annual title (having a crown and/or sash) or any former Jr. Miss Winnebago County Fair Queen will not be eligible to participate.
- 3. Candidates must have parent's/legal guardian's written consent agreeing to the rules and requirements. (See rehearsal schedule for additional details)
- 4. All visible tattoos must be covered with cosmetics or a band-aide and piercings are limited to a maximum of two in each earlobe only. All other piercings must be removed for competition including piercings in the tongue, nose and belly-button (if seen through their clothing).
- 5. Each candidate will be personally interviewed on Sat, 8/10/24 by the judges in a professional interview suit (with skirt or slacks and jacket) Pantsuit or Sunday dress.
- 6. Each candidate will appear on stage in a floor length or tea length formal with shoes of her choice and a Fun Fashion outfit. Fun Fashion should reflect their personality and be from your list of Hobbies & Activities on the application you submitted. They will then give a 30 second speech regarding their Fun Fashion. The use of one note card is allowed. The Fun Fashion will be due for approval and practiced on a specific date set by the Pageant Director.
- 7. Each candidate will be expected to answer one crown bowl question.
- 8. No talent performance is required for the county levels.
- 9. All clothing must be tried on and approved by the Pageant Director. A picture will be taken for documentation.
- 10. All speeches must be given to the Pageant Director on paper by a specific deadline for approval. Speeches will be practiced on stage on a specific date set by the Pageant Director.
- 11. Rehearsals will be on Tuesday evenings from 6:00pm to about 8:30pm and you will be sent a schedule via email once your registration form is received. The night of Mock Interviews may run later that 8:30pm. Rehearsals are subject to change so please be sure to attend each practice. We understand that summer vacations may happen but it is also very important to be committed to this pageant. All absences will be looked at by the judges and if unexcused or excessive there may be a deduction in your score. See rehearsal schedule for details on what is excused and what is unexcused.
- 12. Candidates will be judged as follows Personal Interview (30%), Speech & Communication Skills (20%), Crown Bowl Question (20%), Fun Fashion (15%), and Stage Presence in Formal (15%). The Top 3 will all be asked the same question individually and each judge will award points for a 1st, 2nd and 3rd place ranking.
- 13. No preliminary contest will be held unless deemed necessary by the Pageant Committee. In case of a preliminary competition, all contestants will be notified and it will consist of the Personal Interview and Speech & Communication Skills portion only.
- 14. The newly crowned Jr. Queen will abstain from public displays of affection toward her boyfriends during fair week and at all appearances throughout the year.

- 15. The newly crowned Jr. Queen and her parents/legal guardians will use extreme caution and are encouraged to make certain there are no derogatory photos and written comments on Facebook or other media sites. The Jr. Queen should always portray herself as positive role model throughout the year.
- 16. The newly crowned Jr. Queen is **required to be at the fair all week** unless approved by the Pageant Director and Winnebago County Fair Board prior to competition.
- 17. The newly crowned Queen and her parents/legal guardians agree to participate in all parades, and other events which may arise during the year. Activities connected with the Winnebago County Fair should take precedence over and above all other personal appearances. A list of all required events will be handed out at a rehearsal.
- 18. It is prohibited for the 2024 Jr. Miss WC Fair Queen to participate in any other scholarship or beauty pageants during her reign. If she chooses to do so she will be required to give up her title and all that goes with it (tiara, sash, pin, ring, all gifts and cash awards) to the next eligible Runner-up (Eligibility will be determined by the Pageant Director and Winnebago County Fair Board). This may also disqualify her from competing in the Jr. Miss and Miss Winnebago County Fair Queen Pageants in the future.
- 19. Cash award will not be awarded until the completion of her reign.
- 20. If for any reason the Queen cannot fulfill her duties the title and all that goes with it (tiara, sash, pin, ring, all gifts and cash) will go to the next eligible Runner-up.
- 21. Decisions of the judges are final. Any grievances or objections relative to the contest will be referred to the Pageant Committee of the WCFA. Each judge will sign an affidavit stating that they do not know, are not related to nor do they, or have they ever coached any of the Jr. Miss contestants competing this year.
- 22. Scores will not be given out to the contestants after the pageant. If you would like feedback or have any questions, please contact the Pageant Director for details.
- 23. Expectations of a WCFQ contestant: We understand that you may be upset if not chosen as queen. How you handle this may be a factor if you choose to compete in the future so we expect you remain kind and courteous to the winner and runner ups.

Rehearsal Schedule

- Tuesday 6/18/24
- We will not line up as I want to work on walking, turns and possibly sitting. If you already know the shoes you will be wearing, bring them. If not, please bring any pair of heals to practice in. Written or typed Application and Sponsorship Money is due unless authorized by Pageant Director.
- Tuesday 6/25/24
- Please plan on being here as we will be doing the line-up for the stage and begin working on Grand March, Evening Gown Modeling, Blending and Fun Fashion Modeling. Please try to at least have your taupe heals and bring them to practice in. If not bring any heal to practice in. Typed Application is due.
- Tuesday 7/2/24
- This will be a combined rehearsal with Miss and Jr. Miss due to the 4th of July Holiday.
- Tuesday 7/9/24
- We will be learning the entire Production Number and will continue to perfect it later. If you miss this practice for any reason, it is your responsibility to talk with the Director (or choreographer) to arrange a time to learn it. You will need to purchase a t-shirt designed by our current queens and wear jean shorts and tennis shoes for the Production Number.
- Tuesday 7/16/24
- We will be conducting Mock Interviews, practicing speeches on stage and Paula will also be taking your pictures for the program book so please be prepared. You do not need to have your hair done, just make sure it is nice for a picture. I will need ALL required forms from the girls (NEWSPAPER FORM, APPLICATION and BUSINESS CARD) and APPROVAL of INTERVIEW SUIT, EVENING GOWN, FUN FASHION and SPEECH) The mock judges will have feedback for you and give you pointers on what to work on for the real interview. Please have your family and friends practice giving you questions to answer and treat this mock interview as if it was the real thing.
- Tuesday 7/23/24
- To Be Determined
- Tuesday 7/30/24
- We will use this as a form of dress rehearsal. Please bring all clothing for one last fitting and bring both taupe heals and evening gown heals to practice in. If your dress has a train, I will want you to practice on stage with it as we may need to modify things slightly to accommodate for the train.
- Tuesday 8/6/24
- No Rehearsal due to Boone Co Fair Queen Pageant. You are encouraged to come to Wednesday 8/7/23 Miss rehearsal. Please let Kim know if you will be joining the Miss contestants.

Saturday 8/10/24

-Interviews will be conducted and will do a final dress rehearsal on stage with both pairs of shoes you will be wearing when interviews are finished. You will not need your suits, dresses or swimsuits as we will not be changing cloths. By the time we leave, I am confident that everyone will be comfortable and excited for Wednesday. TIME: and Dress rehearsal from 9 – 11 and Interviews from 11 – 1 (times may be modified depending on the number of contestants). Be at Moss Hall between 8 and 8:30 to prepare. Bring a snack with you so you can grab a bite to eat between events. Lunch will be served after Jr. Miss Interviews (around 1) and will be required as the judges will join us.

Wednesday 8/14/24

- Pageant Day! You will need to be at Moss Hall at the fairgrounds no later than 4:00 pm. Please have your hair done for stage. It is up to you if you want to have your makeup done or if you do once you get there. Once you are there, you will not be allowed to leave until after the pageant is completed that evening.

Rehearsals are subject to change so please be sure to attend each practice. We understand that summer vacations may happen but it is also very important to be committed to this pageant. All absences will be looked at by the judges and if unexcused or excessive there may be a deduction in your score.

Excess: More than 25% of the 8 practices (this equals 2 practices)

Excused:

- 1) You notify the Pageant Director via txt at least 2 hours before the start of rehearsal or have pre-arranged being gone.
- 2) You are still within the 25% excess.

Unexcused:

- 1) No notification or not 2 hours before the start of rehearsal and have not pre-arranged being gone.
- 2) You are over the 25% excess

(Excused and Unexcused applies to being late and absent completely. This is not designed to be difficult but to keep things fair for everyone. I worry when you are not where you should be so, please talk to me and we can possibly work something out.)

Jr. Miss Detailed information for regarding Personal Interview, Crown Bowl Question, Speech & Communication Skills, Fun Fashion and Stage Presence:

PERSONAL INTERVIEWS (30%) are timed events – four to five (4-5) minutes for each contestant to present yourself and your personality. There are no wrong answers. The judges will be especially interested in your mental alertness, sincerity and general knowledge. They may ask personal opinion questions, but there will be no current event questions that you need to "study" for unless you "open the door" by inclusion on your application or in your response to a question. You will be seated across from the panel. Sit up and do not cross your feet. Check to be certain your clothing fits correctly when seated and your skirt is not too tight or short. Be aware of your appearance, vocabulary and manners. Those who are confident and appear relaxed have always done well.

CROWN BOWL QUESTIONS (20%): These questions are usually more difficult than general interview questions and may refer to general current events or issue.

SPEECH & COMMUNICATION SKILLS (20%): As queen you may be called upon to speak to groups or individuals throughout your reign. You must be comfortable speaking and be able to express yourself naturally. You will give a 30 second speech regarding your fun fashion outfit you have chosen. We do not time the speeches but they do at the State Miss Competition and do deduct points. You will be using a hand-held microphone, no podium. We will practice during a specific rehearsal to become comfortable on stage.

- *Singing, poems and sign language as part of your presentation is not allowed.
- *Remember, this is an opportunity for the judges to see how you will speak before and respond to a crowd.

FUN FASHION (15%): Contestants will model an outfit of their choice in this upbeat competition. Contestants should choose an outfit that expresses their personality and should be from your list of Hobbies/Activities on the application you submitted. Props such as sunglasses, purses, umbrellas, jackets, hats, etc. may be used, and outfits may have a theme. Swimsuits/bodysuits will not be allowed. We will practice during a specific rehearsal to become comfortable on stage.

STAGE PRESENCE/FORMAL (15%): This competition is designed for the contestant to make an on-stage statement of her personality, gracefully moving with poise and confidence. Choose a dress that reflects your own individual style. Choose one in your best color that compliments you and makes you feel like a queen; but follow these rules:

- It must be floor or tea length.
- Splits in skirts must be no further than 4 inches above the middle of the knee and will be checked by pageant director.
- Hoop skirts are not recommended as the stage is crowded.
- Strapless dresses will be required to have straps added (NO STRAPLESS).
- Choose accessories to enhance your look, not overwhelm you. Larger earrings draw attention to your face. Unless they definitely make the dress, we suggest that you do not wear gloves.
- DO NOT wear powder or lotion that has glitter in it. The intense lighting will make you look like a Christmas tree on stage.
- There are many pretty formal shoes available; however, you do not want to draw attention to your feet rather than your face. Please choose a small heal, sandal or flat that fits properly and that you are able to walk in gracefully.

To avoid surprises, it is wise to try your interview suit/dress, fun fashion and formal on the week before the Pageant for a final fitting and to get the total look.

- **Approval of Interview Suit/dress, Speech, fun fashion and formal is required and photo taken by the Pageant Director and approved by a date to be determined. If anyone is having problems finding the appropriate attire, please notify the Pageant Director for assistance.**
- **Attendance and responsibility will be looked at by the Judges. Please see the rehearsal schedule for the attendance policy. Along with attendance, the judges will also see if contestants were responsible in getting their attire and speech approved on time or if other arrangements were made.**
- **A \$75.00 sponsorship (entry) fee is required from each contestant and due on the registration deadline (or at the latest the first rehearsal on Tuesday, June 18, 2024 unless authorized by the Pageant Director). Contestants may have up to 3 sponsors; each sponsor will receive a business card size ad in the pageant program and receipts are available to give your sponsors for tax deductions. If a business card is not provided there will not be an ad placed in the pageant program for them but their name will still be read.**
- **A **typed application** is due by the second rehearsal on Tuesday, June 25, 2024 unless authorized by the Pageant Director.**
- **There is also a **VIP Dinner** on Monday, 8/12/24 in which up to 2 of your sponsors plus one guest each are invited to attend, in gratitude for their support. Invitations will be provided to you to give to the 2 sponsors of your choice during one of the rehearsals. Contestants will get up on stage (with their Miss of the same #) and introduce themselves with Contestant # and Name and then will thank all of their sponsors. This is a **REQUIRED** event unless authorized by the Pageant Director.**

Thank you for your interest and I hope to see you at the Information Meeting on Tuesday, June 4, 2024 in Moss Hall at the Winnebago County Fairgrounds at 7:00pm. If you cannot attend this meeting, please contact me to get a rehearsal schedule and be sure to make the first rehearsal on Tuesday, June 18, 2024 also in Moss Hall at 6:00pm. Please feel free to contact me with any questions regarding the pageant or rehearsals. I can be flexible but also need to be fair to all and commitment from all of our contestants. Our most important goal is to have fun, so come join us!
