1. This show is open to amateur artists only. Exhibitor in V3-Art must be 19 years or older. Each entry must be the work of the exhibitor. Limit of four (4) entries per exhibitor.
2. Entry fees are \$2.50 per entry and exhibitor is required to purchase a \$10.00 Exhibitor's Pass regardless of 4-H participation.
3. Entries may be in mixed media, oil, watercolor, pastel, drawing, collage, charcoal, 2-D glass, woodcut, acrylic, etc. No textiles or 3-D artwork, crafts or copies will be accepted. Entries must be dry, properly presented, framed (maximum 40" x 40"), and wired for hanging on a single hook. No saw-tooth or single hangers will be accepted. .
4. All entries must be received by 4:00 P.M. August 3, 2024. Fees must be paid by August 3, 2024.
5. All exhibits are to be brought to Building 5 (Aqua), inside of Gate 2, between 10:00 A.M. and 6:00 P.M. on Monday, August 12, 2024. Exhibitor pass, entry tags and other information may also be picked up at table in front of building at this time.
6. Judging will be between 10:00 A.M and Noon on Tuesday, August 13, 2024. Judging area will be closed to the public during that time.
7. Entries will be released between 4:00 P.M. and 6:00 P.M. on Sunday, August 18, 2024. Premium checks will be issued at this time. Superintendents are not responsible for items not picked up by 6:00 P.M., Sunday, August 18, 2024. All exhibits are required to remain in the Fine Art Exhibition area until 4:00 P.M. that same day.
8. Any entry shown that is for sale must have the price clearly visible to the public, and if sold, a 15% commission is due and payable to the Winnebago County Fair Association. Entry must remain at the fair for the duration of the show.
9. Entries will be divided into categories and may be changed upon the decision of the judge. Superintendents reserve the right to reject any undesirable subjects. Judges decisions are final.
10. ALL APPLICABLE GENERAL RULES AND REGULATIONS AND DEPARTMENTAL RULES APPLY.
